#### **Governance Report:**

The Board of Directors and Registrar participated in a board development workshop in September 2013. The focus of this year's development workshop was financial governance. Stephanie Coldwell CA, facilitated this workshop and shared her expertise to assist the Board to review and update financial policies.

The outcomes of the financial workshop are:

- Improvements in definition and allocation of restricted and non-restricted assets
- Multiple year financial forecasting
- Improved budget planning and development

The Board also collaborated with several other health regulators to develop an interdisciplinary Board development workshop to be delivered in June 2014.

Looking forward to 2014 the Board identified two significant milestones;

- 1. The Respiratory Therapists Society of Nova Scotia was incorporated in 1964 and transitioned to the Nova Scotia College of Respiratory Therapists in 2008. This means that 2014 marks 50 years of Respiratory Therapists practicing in Nova Scotia.
- 2. The NSCRT has passed our five year anniversary as a regulatory body.

The Board of Directors developed plans to recognize each of these milestones by:

- 1. Planning a 50<sup>th</sup> Anniversary Celebration to take place with our 2014 Annual General Meeting to be held with the Atlantic Respirology and Critical Care Conference in November 2014.
- Strategic Planning that includes engaging all NSCRT members to develop our strategic direction
  for the next three to five years. A consultant has been selected to work with us over several
  months to engage members through surveys and workshops and will submit a final report to the
  NSCRT Board of Directors in January 2015.

#### 2013-2014 Report:

The Credentials Committee served as the steering committee for a project funded by a grant from the NS Department of Labour and Advanced Education under the International Qualification Recognition program. The NSCRT project titled "Facilitating the clinical assessment and recognition of international qualifications and integration" was completed in March 2014. This project was the primary focus of the Committee for this year.

Key changes include the formation of the Nomination Committee no later than Apr. 1<sup>st</sup> in an election year. Calls for nominations to replace upcoming board vacancies will be sent out Apr. 1st and will close Sept. 1<sup>st</sup> in an election year. #### **2013-2014 Report:**

The committee has met 3 times this past year in Halifax and addressed inquiries by the usual correspondence work through emails/phone calls. The majority of meeting time has dealt with: **The Role of Anesthesia Assistants Policy Paper** 

The majority of PPC meeting time has been in the initial development and ongoing discussions around AA Policy Paper development. The paper was ready for stakeholder consultation by the end of March, 2014. Once feedback is received the Policy Paper will be updated if required and will go to the NSCRT Board of Directors. The completed paper will be presented to all health regulators through the Regulated Health Professions Network.

The committee has received/discussed questions and provided responses to ongoing practice questions from across the province and provided guidance where appropriate. These include:

- -Review of the Regulated Health Professional network document regarding assignment and delegation of RT duties
- -Pandemic Competencies mapping for teams through Health Human Resources (HHR) planning
- -Intubation and LMA skills for Midwives
- -Clinical competencies for RT's in the Valley; ie. Minimum number of required intubations and arterial line insertions

The committee will continue to develop College frameworks for Professional Practice Guidelines to guide respiratory therapists and help them navigate through various professional practice issues.

We continue to collaborate and seek guidance from other Regulated Health professions such as College of Respiratory Therapists of Ontario, College of Physicians and Surgeons of Nova Scotia and College of Registered Nurses of Nova Scotia.

There will be a call for an additional member to serve on the Professional Practice Committee to replace a member no longer serving on the Committee.


### **Registration:**


There has been modest growth in membership since the first registration in 2008 as identified in Table 1. On-line registration renewal is working well and simplifies the renewal process for both members and staff.

#### **Professional Portfolio Audits:**

Professional Portfolios are audited annually as a quality assurance activity to insure that respiratory therapists practicing in Nova Scotia are continually reflecting on their practice, maintaining required competencies and currency by participating in continuing education and professional development.

The Registrar completed portfolio audits of 26 members who were randomly selected during the 2013 registration renewal. All audited members met the requirements defined by the NSCRT Continuing Competency Program.

### **External Relations**

#### **Provincial:**

The NSCRT is a member of the Nova Scotia Regulated Health Professions Network. In 2012 the Regulated Health Professions Act was proclaimed and in 2013 the Regulations were approved. The NSCRT Registrar is the representative of the College on the Network Council.

The Network began to work under statute with five defined priorities for the first two years of incorporation. Bruce Holmes was hired as Executive Director of The Network and will focus on the deliverables under the five priorities that were agreed upon between The Network and the Department of Health and Wellness.

The Provincial Review Officer continues to collaborate with regulatory bodies to increase capacity for compliance with the Fair Registration Practices Act. Through quarterly meetings there is sharing of best practices and updates on regulatory issues. The NSCRT is now reporting registration statistics to the Review Officer annually and likely will be scheduled for a complete review in 2015.

#### **National:**

The NSCRT Registrar and President represent the College at the National Alliance of Respiratory Therapy Regulatory Bodies (NARTRB). In 2013-14 the NARTRB completed a project to develop a national assessment process for internationally educated health professionals (IEHPs). Through this project the NARTRB identified a common academic standard against which IEHPs will be assessed. At this time we have agreement on the assessment process and each province can use this process.

The NARTRB has initiated the preliminary steps to revise and update the Respiratory Therapy National Competency Profile. This document defines the required entry to practice competencies and therefore is the foundation upon which school curricula and the entry to practice exam are built. While it is customary to update the profile every five years there is a desire among NARTRB members to revise this from a profile to a framework. The framework will better define performance criteria and will be more than a simple task list. A project consultant search is underway and the anticipated release date of the framework will be 2016.

Atlantic Connection is preparing to work with the NARTRB to develop a Self Assessment Readiness Tool<sup>®</sup> for Respiratory Therapy. A consultant will be selected as a subject matter expert to work with the team to develop the SART<sup>®</sup> for Respiratory Therapy. This tool is targeted to IEHPs to allow them to better understand Respiratory Therapy practice in Canada and to assess whether their education and experience may position them to enter practice through a bridging program. Upon completion in February 2015 the SART<sup>®</sup> will be maintained by the Nova Scotia Community College IT department and each member of the NARTRB will have links to the tool on their respective websites.

#### INDEPENDENT AUDITOR'S REPORT

To the Members of: Nova Scotia College of Respiratory Therapists

We have audited the accompanying financial statements of Nova Scotia College of Respiratory Therapists which comprise the statement of financial position as at March 31, 2013 and December 31, 2011 and the statements of operations, statement of net assets, and cash flow statement for the years March 31, 2013 and December 31, 2011, and a summary of significant accounting policies and other explanatory information.

#### Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

#### Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained in our audits is sufficient and appropriate to provide a basis for our audit opinion.

#### Opinion

In our opinion, these financial statements present fairly, in all material respects, the financial position of Nova Scotia College of Respiratory Therapists as at March 31, 2013 and March 31, 2012 and its financial performance and its cash flows for the years then ended in accordance with Canadian accounting standards for not-for-profit organizations.

## Nova Scotia College of Respiratory Therapists NOTES TO THE FINANCIAL STATEMENTS MARCH 31, 2013

#### 1. PURPOSE OF THE ORGANIZATION:

The Mission of the Nova Scotia College of Respiratory Therapists is to promote excellence and leadership in the practice of Cardio-Respiratory Care.

#### 2. ADOPTION OF ACCOUNTING STANDARDS FOR NOT-FOR-PROFIT ORGANIZATIONS

These financial statements were prepared in accordance with Part III of the CICA Handbook - Accounting ("Part III").

The Association's first reporting period using Part III is for the year ended March 31, 2013. As a result, the date of transition to Part III is April 1, 2011. The Association presented financial statements under its previous Canadian generally accepted accounting principles ("CGAAP") annually to March 31st of each fiscal year up to, and including, March 31, 2013.

As these financial statements are the first financial statements for which the association has applied Part III, the financial statements have been prepared in accordance with the provisions set out in Section 1501 of Part III, First-time Adoption by Not-For-Profit Organizations.

The association is required to apply Part III effective for periods ending on March 31, 2013 in:

- a) Preparing and presenting its opening statement of financial position at April 1, 2011; and
- b) Preparing and presenting its statement of financial position for March 31, 2013 (including comparatives amounts for 2012), statement of operations, statement of changes in net assets, and statement of cash flows for the year ended March 31, 2013 (including comparatives amounts for 2012) and disclosures (including comparative amounts for 2012).

#### 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Presentation

The financial statements have been prepared in accordance with Canadian generally accepted accounting principles for Not-for-Profit organizations.

(b) Revenue Recognition

Membership dues and assessment revenue are recognized using the accrual basis of accounting. Deferred revenue represents license fees paid during 2013 for the 2014 year.

#### 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Cont.)

#### (c) Equipment

Equipment is recorded at cost. Depreciation is provided annually at rates calculated to write-off the assets over their estimated useful lives as follows:

#### (d) Funds

#### Contingency Fund

The purpose of the Contingency fund is to maintain reserve funds necessary to fund the legislated obligations of the College. The size of the fund is determined as a part of the annual budgetting process. During the year \$4,916 was spent for legal fees.

#### Special Purpose Fund

The Special Purpose fund is maintained to provide fund for projects that have a defined purpose that relates to the objects of the College and the current strategic plan. The board determines the percentage of the Special Purpose Fund that can be approved for use in a given fiscal year.

#### (e) Financial Instruments

The College's financial instruments consists of cash and short-term investments, amounts receivable, longterm investments, accounts payable and accrued liabilities. The fair values of these financial instruments approximate their carrying values, unless otherwise stated.

#### (f) Use of estimates

The preparation of the financial statements in conformity with Canadian generally accepted accounting principles requires the College's management to make estimates and assumptions that affect the amounts reported in the financial statements and related notes to the financial statements. Actual results may differ from these estimates.
